Approval of Armour & Sons Payment #1 & #2 totaling \$69,047.10 – Motion Greg Pocius second Todd Larsen to approve the payment to Armour & Sons for \$69,047.10. all in favor, Motion carried 5-0.

Motion to adopt the draft 2019 Budget totaling \$2,273,490.00 – this includes the 300 Main Street Loan for renovations and No tax increase. Motion Lee Ann Miller second Sarah Knickerbocker to adopt the 2019 Budget. All in favor, Motion carried 5-0.

Ordinance No. 396 – Adopting 2019 Tax Rates. Motion Greg Pocius second Sarah Knickerbocker to adopt Ordinance No. 396 2019 Tax Rates. All in favor, Motion carried 5-0.

Monthly Report A monthly activity report was submitted to Council by Mrs. Klepfer.

<u>Finance Report</u>: Mrs. Klepfer read the summary Financial Report. For the Period January 1, 2018 through November 30, 2018 Total Income for General Fund and Liquid Fuels Funds was \$618,607.34 and Total Expenditures was \$579,007.55 for a net gain of \$39,599.79. General Fund experienced a net gain of \$19,649.09. General Fund Assets total \$400,297.52; Capital Fund Assets total \$181,933.06 and Liquid Fuels Fund Assets total \$62,629.80 and Fire Museum Fund Assets of \$19,307.71 for a combined Assets total of \$640,293.93.

<u>Old Post Office:</u> A donation has been made of two loads of poplar wood for use on the Old Post Office. Donor would like to see a plaque on the building when finished.

<u>Historical Committee</u>: A meeting is scheduled for January 2019 to wrap up the recommendations of the Historical Markers and seek Councils comments and approval. Will also be working on the Observation Deck and recommendations for historical and educational signage.
